### Note:

1. The Vendor approval is conveyed based on the records/credentials furnished by the Vendor. Equipments/Materials shall be supplied as per KPTCL Technical specifications duly obtaining approval for relevant drawings, GTP & Type test reports from the competent authorities of KPTCL before offering for inspection. This approval is **valid for a period of two years i.e., upto 11.02.2022** and also the approved Vendors shall submit their request for renewal of approval Three months in advance before the expiry of validity.
2. Vendors shall furnish, to the concerned KPTCL Authorities, all the relevant valid type test reports of not older than 5 years, issued by the **CPRI/ERDA/MSME/NSIC/GPRI laboratories**, for the **same** type, rating and voltage class of Equipment/Materials, proposed to supply to the KPTCL projects, during drawing approvals, inspection of equipment/materials etc. The Type test Certificates should be furnished for all the tests conducted as per the relevant IEC/IS/Technical specifications of the equipment/materials proposed to supply to KPTCL project.
3. Vendor approvals are considered based on the type test reports of **same/higher** type, rating and voltage class of Equipment/Materials for which vendor approval is requested. However, **before supply of equipment/materials to KPTCL**

**projects**, through EPC Contractors, Vendors shall invariably furnish, to the concerned KPTCL Authorities, the valid type test reports of not older than 5 years, issued by **CPRI/ERDA/MSME/ NSIC/GPRI laboratories**, for all the tests conducted as per the relevant IEC/IS/Technical specifications, for the **same** type, rating and voltage class of Equipment/Materials as specified in the technical specifications of KPTCL's project and shall obtain approvals for each project, for the Type test reports, QAP, GTPs and drawings of equipments/materials, before offering for inspection.

4. In case vendors do not have type test reports for the **same** type, rating and voltage class of materials/ Equipment required for KPTCL, but are having type test reports for **higher** type, rating and voltage class of materials/ Equipment, then such Vendors, **before supply of equipment/material to KPTCL** through EPC contractors of KPTCL project, shall conduct type tests as per the relevant IEC/IS/Technical specifications of KPTCL on **same** type, rating and voltage class of equipment proposed to supply for KPTCL project at **CPRI/ERDA/MSME/ NSIC/GPRI laboratories** in the presence of KPTCL representatives without extra cost to KPTCL and without affecting delivery schedule.
5. KPTCL reserves the right to insist for conducting type tests as per relevant IS/IEC/KPTCL technical specifications at **CPRI/ERDA/MSME/NSIC/GPRI laboratories** as and when required though the type test reports are less than 5 years old.
6. KPTCL reserves the right to call for any document/credentials for verification during drawing approvals/inspection of materials/equipment by KPTCL authorities, to ascertain the manufacturing experience/performance/technical suitability of the equipment/ materials. Further KPTCL reserves the right to withdraw/ cancel the vendor approval issued, in case vendor fails to furnish valid documents/credentials to KPTCL for verification, supply of poor-quality/defective materials/equipment to the KPTCL projects, poor performance, poor after sales service, deviations in the technical specifications of KPTCL, misleading to the Corporation etc., by the vendors, without prior notice and assigning any reason for such decision.
7. Further vendors shall comply with the qualifying requirements, Terms and Conditions stipulated for the equipments/materials for which empaneled as a vendor and any amendments thereon, during the validity period of this vendor approval.
